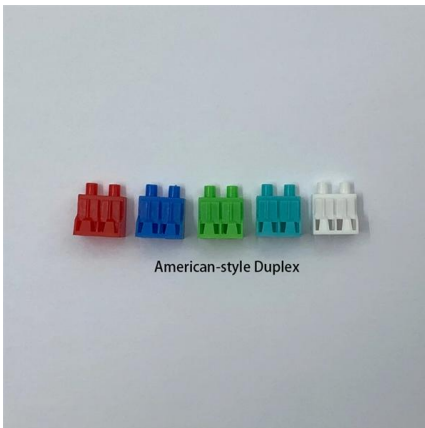
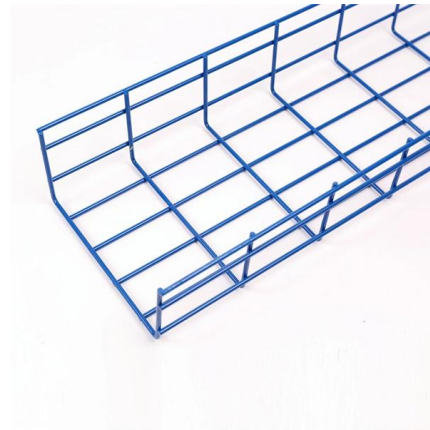

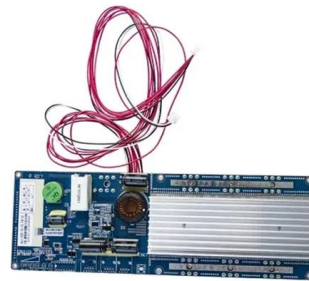

Generally, the entire CCC Certification process of an ITE product may take between 2 - 4 months (if the manufacturing location has not been CCC certified)



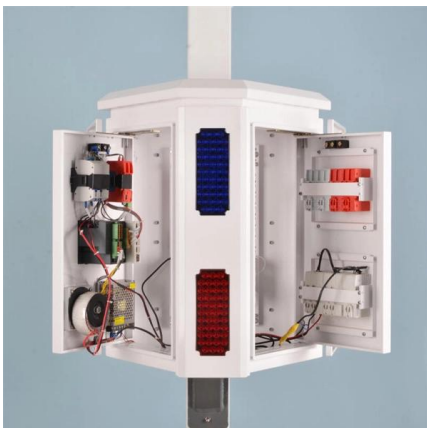
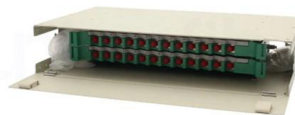

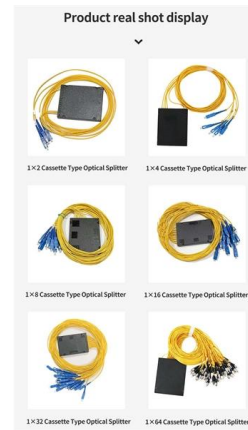
