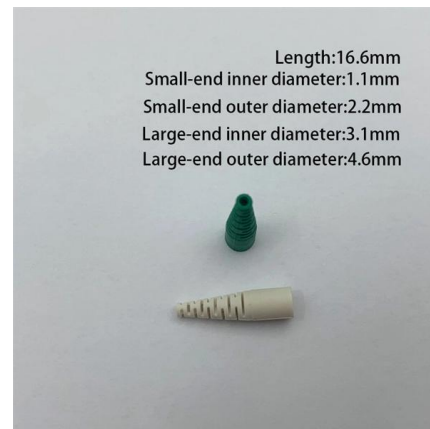

In theory, goods are presented to customs on each occasion and cleared with duty being paid, where applicable. They then enter free circulation and can move anywhere in the EU as EU goods.



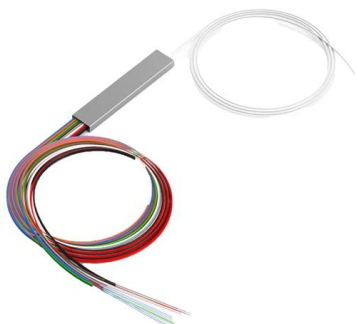
